MR EVANS Mr Speaker it is with regret that this House records the passing of **Katherine Daisy Adams-Friend** who was born in November 1930, the youngest child of Amy Ruth Adams (nee Christian) and Ephraim Henry Adams (Pumper). She was educated at the Norfolk Island School and took her first job as a nursing aid at the hospital, in what is now Bishop's Court near the Mission Chapel. She was trained by Matron Heather Napier, with whom she formed a lifelong friendship. When Heather returned to Sydney, Kath went with her and worked in hotel management. During this period, Kath was chosen for a Women's magazine spread. When her mother fell ill, Kath returned home to look after her parents. Ernie Friend came to Norfolk to take up the position of Agricultural Officer with the Administration. Through her brother Bill, Ernie met and later married Kath. In 1960 Ernie got a job with the Northern Territory Government and they moved to Darwin along with Kim, Robert, and Garry. Shortly after Stuart and Karen came into the world to complete the family. Kath was a talented, sport's loving, independent, strong and smart woman. She was a good tennis and golf player, playing tennis at the Methodist Courts and golf with Bill at the Golf course. In Darwin, Kath took on several jobs before becoming a successful business woman, owning six fashion dress shops in Darwin, Gove and Katherine. She was a leader in voluntary community works starting the Darwin Spastic Centre which acknowledged her efforts by naming a building in her honour. She ran the Spastic Association Miss Australia pageant for two years as well as a number of other fund raising events. Kath opened her house to her brother Stephen 'Brud' who worked in the Northern Territory as a bull dozer operator, as well as to many of her nephews and nieces, including Julie and Steven Adams dar for Gindie's, Wayne 'Doggy' Adams to commence a plumbing apprenticeship, Fla Adams who commenced nursing training at the Darwin Hospital, Kelvin Adams to do some years at high school and after their father passed away, Kelvin's younger sister Alison, who completed year 8 at Darwin High School with Robert and Garry. While Darwin was some distance from Norfolk Island this did not limit Kath from going home or from visiting her Aussie based brothers whenever possible. A year before Cyclone Tracy devastated Darwin, Ernie was transferred to a job in Bundaberg so the family left Darwin. Kath sold her businesses and after a short stay in Gove then Bundaberg, they moved again, this time to Brisbane where Kathy and Ernie lived until their retirement. Before leaving Darwin, Kath was named person of the month in the Darwin Newspaper and her community work and philanthropy was acknowledged by the Darwin community. Once they were settled in

Brisbane Kath went back to work which included working in a Butcher shop in Indooroopilly and a gift shop in Yeronga before owning two florist shops in the City. They allowed her skills in design, colour and arrangement to come to the fore. One of the florist shops was located at the old Roma Street Railway Station, an area known to be a night time refuge for a number of homeless people. Each morning when Kath arrived to open the shop she would buy them a hot drink and toasted sandwich from the Café across the street. Upon Ernie's retirement, Kath and Ernie built their house at Steele's Point and moved back to Norfolk. Here, she bought the Palm Court Café and for a period they managed Branker House as a restaurant. During this period Kim, Garry and Karen were also living on Norfolk and could assist Kath in her business ventures. She was a member of the Norfolk Island Hospital Management Committee and contributed greatly to its work. Living on Norfolk was a very enjoyable period of their lives. Kath was able to reconnect with Bill and Taggart and their families as well as many of her old friends. Sadly due to their health, Kath and Ernie had to move back to Brisbane although they returned to Norfolk as frequently as they could. To Ernie, their children Robert, Kim, Garry, Stuart, Karen and their children, Adam, Chris, Jack and Emily; to Kath's extended family and her many friends here and overseas, this House extends its sincere sympathy. May she rest in peace.

A person ceases to be an adult healthcare member when a) the person leaves Norfolk Island with the intention of not returning to Norfolk Island within the next 180 days and that intention is indicated by the person on the prescribed form or b) the person has been absent from Norfolk Island for a continues period for 180 days but notwithstanding that, a person who has so ceased to be an adult healthcare member may again become under section 8 an adult healthcare member. In subsection 9(1) the prescribed form means Form 8 in Schedule 1 to the Immigration Regulations 1984 or such other form as prescribed in regulations. Thank you Mr Speaker

for a while which is why I've put together a working group which was chaired by our fellow Member here Mr Porter, and they've done a lot of good work on identifying short and longer term issues. We will have the rock that's available in portion 44A and I have asked that there be a budget allocation which will be less than \$2000 to actually get a surveyor in and assess the quantities of rock that is on that site at this time. There was a previous survey done but the information would now be well and truly out of date and its worth our while knowing what quantities we have and what likely time frame that will give us. MR NOBBS Thank you Mr Speaker a question for the Minister for Immigration. I understand Minister that in 2011 the Norfolk Island Government and the Commonwealth Government's agreed to amend the Immigration Act and that amendments were made in 2012 to open up Norfolk Island's immigration. Is it correct that at the same time as the original agreement was made in September 2011 it was agreed that the Commonwealth would review the impacts of the amendments by 30th June 2014 including economic, environmental, land use and social cultural impacts

MS ADAMS Thank you Mr Speaker. I think Mr Nobbs is referring Funding Agreement of September 2011 clause 11 in which, yes, it requires that 1. Norfolk Island will by 31 October 2011 amend any current restrictions to allow self funded retirees who are citizens to live within the Norfolk Island territory as part of the permanent population 2. by January 1, 2012 remove immigration restrictions or permanent residents arriving as tourists on Norfolk Island and 3. 30th June 2012 remove immigration restrictions on Australian citizens arriving and remaining on Norfolk Island to facilitate the extension of the Migration Act 1958 of the Commonwealth to the Norfolk Island Territory. This condition you are quite correct, is subject to the Commonwealth outlining an implementation plan for access to Commonwealth benefit schemes, including social security and Medicare and in addition to that, in relation to these reforms the Commonwealth will review their impact by 30th June 2014 including economic, environmental, including land use and social cultural impact. So that's exactly how it was and it remains today and in short the answer to your question is no.

Yes, there has been discussion between the Chief of Staff and CEO about the fact that the Commonwealth has yet to review their impacts and this is a matter that we will be discussion with the Commonwealth during the Funding Agreement negotiations

MR SHERIDAN Thank you Mr Speaker and thank you Mr Evans for the question, just an update on the fuel situation here on Norfolk Island, last week the last discharge from the Ball Bay tanks were delivered to the service stations but we were fortunate enough to have 30,000 litres arrive on the Norfolk Guardian which is approximately ten days worth of fuel. The tanker did arrive earlier this week at this time and up to when I left for work this morning, as I overlooked Ball Bay the tanker was not in the Bay discharging, but I have had since that time advise calling for a special meeting of EXCO tomorrow afternoon to revoke the fuel emergency and I've been informed by the service that the discharge of the fuel should be completed by today and overnight so it's depending on whether or not that tanker is discharged sufficiently then EXCO will be held tomorrow afternoon and the fuel emergency will be finished

MS ADAMS Thank you Mr Speaker if I could just add to my earlier response please to Mrs Ward that I should have mentioned too in my response that as you are aware I brought to Members recently my concern of some of the impacts which are taking place at this time where people who have arrived on Norfolk Island under this provision which was put in place for holders of unrestricted entry permits and also residents under section 28(a) of the Immigration Act, are now applying for exemption from payment of the Healthcare Levy on the grounds of insufficient income being earned in a levy period and I have asked the Healthcare Manager to have discussions with the statisticians who are compiling the statistics which are to go up on line to include those provisions just so that, that's on the table. MR PORTER Thank you Mr Speaker a question to the Minister for Finance, Mr Sheridan given that there may be some doubt about completing that, will that lack of funding be factored into the upcoming budget, reflected in the budget will be discussed at this House before the implementation in the new year

MR SHERIDAN Thank you Mr Speaker, and thank you Mr Porter for the question, no, it actually won't be factored into the budget for the next financial year, as that \$4.4m is for the current financial year. The Appropriation Bill that we'll be looking at, at the next meeting will be for expenditure within the next twelve months. Now I realise that if all of those funding milestones aren't met, the full \$4.4m may not necessarily be received. This means that the Government will have to use reserves or what we would deem to be reserves in our revenue fund to meet that shortfall, which we are already doing because the financial year, the end is virtually upon us, and the last payment of \$1m would not be received until some time in the next financial year, so even if they payments were received, the \$4.4m they would not be fully received until after the end of the financial year, which means that we would have to use what funds we have in the revenue fund to carry out the expenditure that this House has approved some twelve months ago, and again back in March, so it is a concern but the non receipt of those funds will not impact upon the budget for next year

MR PORTER Thank you Mr Speaker, a supplementary question, perhaps if there was a significant amount of money missing that would stretch our already depleted reserves to the extent that it would make life difficult I believe. Do you concur with that

MR SHERIDAN Thank you Mr Speaker, yes Mr Porter is very correct in what he's saying, yes it will put pressure on our reserves if we do not receive the \$4.4m. Now those dollars were originally allocated to Norfolk Island for essential services in education, policing, health, and some public services wages and utilities. Unfortunately, if we do not get the \$4.4m those funds that have been allocated to those areas from the \$4.4m may mean that those areas may suffer to some degree. I don't believe that they will because I believe that the Service has indicated that they will complete the majority of the milestones, the question is whether or not the Commonwealth will then pay us funds that they haven't delivered prior because we haven't completed some of the milestones within a certain time frame. If we have since completed those milestones will the funds be forthcoming. We haven't been able to get a response to that and so we are working on the pretext that we will receive the majority of the money and for the next financial year with the allocation in the Federal budget of \$7.5m for the Norfolk Island Government we can only go into discussions on the Funding Agreement next month with the Commonwealth and go into our next meeting with the Appropriation Bill assuming that we will receive the full \$7.5m for what they call essential service delivery and this is what we'll be stressing to the Commonwealth, this is what the funds are then costed towards. It is the funding and the service provision of the services that the Norfolk Island residents must have

MRS WARD Thank you Mr Speaker it is the same topic to the Chief Minister if I may. Given that at the last sitting of the House Members were made aware that the Chief Executive Officer of the Norfolk Island Administration had expressed his concerns at a number of issues regarding the Funding Agreement milestones, will the Chief Minister inform the House what exactly those concerns were and what the Chief Minister has done to address them

MR SNELL Thank you Mr Speaker, and thank you Mrs Ward for the question, it's overarching, the Chief Executive Officer, has expressed his concerns at some of the conditions relating to the Funding Agreements and I relate in particular to difficulties that they have experienced. For example, the Public Service Bill 2013. The Public Service Bill was a milestone in the December 2012 Funding Agreement between the Commonwealth Government and the Administration of Norfolk Island. This Funding Agreement sent obviously to the Assistance Secretary to the then Department of

Regional Australia, Local Government, Arts and Sport, Miss Robyn Fleming, and it was completed and advised and the amount of \$100,000 was paid and received by the Administration for completing that milestone, but unfortunately, and this is a classic example of some of the difficulties that have been experienced by the Service, is that in October 2013 the Department advised that a number of issues relating to the Bill on 0th January 2014 wrote and addressed these issues, despite the Department advising completion of the milestone in August 2013, the Administration was advised that the Public Service Bill is inconsistent with the Australian Public Service standards and the need to adopt public sector values. So even though it was signed off, they have now been asked to complete other specific issues regarding the Public Service Bill, even though it was signed off, and these are what has been termed that they've been asked to design a bridge and now they've been asked to build it and it's becoming difficult and they are experiencing some difficulty in this area. That is just a classic example but we are working our way through it. We have addressed these matters in letters to the Minister, and hopefully we'll get some response in due course.

MR SHERIDAN Thank you Mr Speaker, and thank you Mr Nobbs for the question, no request has been received from the operators of this proposed new airline to operate into Norfolk Island. Myself and the Chief Minister did have a meeting with Mr Preschelt some time ago in regards to his thought of where he would like to go and he indicated at that time that he was thinking of introducing a new airline into Norfolk Island later this year. At this point in time there's been no advise to the Norfolk Island Government that he officially intends to commence that service and no request has been received from him to land at Norfolk Island but just considering that question, under our legislation, there is nothing that we could do to facilitate his not landing here. If he complies with the requirements under the Airport Fees Regulations which is a bond of \$500,000 I think that's the only requirement of the Norfolk Island Government for somebody to operate a service into Norfolk Island. There is virtually nothing that we can do to stop an airline commencing. It is an open skies policy as Australia has, and if they tick all the boxes there would be nothing that we could do to facilitate the stopping of this

MR NOBBS So what you are saying is that no request has been received and no approval has been given for, and we're looking at a different situation aren't we Minister, that we're not looking at a drop in and flippy flying out the next day, or what have you, we're looking at a complete service, a regular use of the airport and facilities, and is it correct that what you are saying that no request has been received and there is definitely no approval given

MR NOBBS Thank you Mr Speaker a different question, to Minister Adams. I refer to the matter in relation to the Employment Conciliation Board, a little while ago and I seek an update. The Board in July last year recommended a rewrite of the Employment Act and immediate promotion for fair employment practices. What has been done in relation to that

MS ADAMS Thank you Mr Speaker. Mr Nobbs is quite correct. The Employment Conciliation Board Annual Report 2012-2013 from memory was tabled in this House back in November last year and back at that time I had, back in November, by email contacted Mr Massicks who had provided me with an advance copy of the report and advising him that it would be tabled in the House and at the time I did mention to Mr Massicks that I take note of the Board's conclusion that a complete rewrite of the Employment Act is well overdue. He raised a number of concerns with me when we met as a Board earlier in the life of this Assembly and I recall making the comment that there were consequential changes being flagged as a consequence of the passage of the Immigration Amendment No 2 Act 2012 and the following was subsequently identified. I don't know if you want me to go into all this detail at this time, I had planned to do it at the time of moving the motion for the appointment of Mr Massicks....

MR NOBBS No. I just want an update

MS ADAMS Okay. So what I was going to tell you at that time, was that a review of the Employment Act is on the 14th Legislative Assembly's Legislative Programme but at this point in time it's in a queue

MR NOBBS Thank you Mr Speaker just on the same subject actually but to the Minister for Finance, Mr Sheridan I think I asked him when the Public Service received their wage increase would he be looking at the basic wage situation here, he said, from memory and if I'm wrong Tim I'm sorry, but he was looking at it. Has there been any further action in relation to a basic wage increase

MR SHERIDAN Thank you Mr Speaker and thank you Mr Nobbs for the question. I understand where Mr Nobbs is coming from. Employment is actually in Minister Adams area and it may be back in mine by the end of the week, but the intent was to look at the minimum wage. I think there was some legislation passed late in the previous Legislative Assembly which facilitated some external review of that, but the main item that we do need to be able to factor in an increase in the minimum wage is to access Norfolk Island's own Retail Price Index. At this time that is in a queue with the Service to be completed. Up to the last ACIL Tasman Report, the fellow who did that did a lot of work, or one of his offsidars did a lot of work on the Retail Price Index, he virtually made a new one for us which started at a new date and a new year and the problem with it is that our legislation needs to refer to the new starting date and the new system and those problems haven't been able to be worked out with the Service at this point in time. I'm aware that it is on the Service's agenda. When it comes to the top, I'm not aware of. I have chased this many a time but that is one of the main items that we would need to facilitate the increase in the basic minimum wage

MR NOBBS Thank you Mr Speaker a question for the Minister for Health, can you update the community on what is happening with the Norfolk Island Hospital. There was a Nexus Report put out about the possible closure of the Hospital, and we seem to have gone very quiet on it and I wonder what has actually happened to that recommendation and progression or otherwise of the report

MS ADAMS Thank you Mr Speaker it might seem to be silent on the face of it but it's not behind the scenes. Certainly there's a lot of discussion going on and I'm continuing in fact to receive submissions around the Nexus Report. Through the Chief Minister's office I have received letters from Dr McNamara, Dr Robbins, Dr Sexton, in recent times and I've sent those off to Minister Briggs at that time with an

accompanying letter just explaining their concerns and the need, the ongoing need for proper consultation at community level and at hospital staffing level which did not happen with Nexus. By their own admission, they didn't have the time to do that consultation and just last Friday, the Director and I had a teleconference with a firm with whom the Director is looking to enter into a possible arrangement to come in the last week of June to undertake that process and I really can't give you any more of an update, to undertake the community consultation process and the Hospital process, there probably will be a questionnaire that's given to the community at the time, and out of that hopefully will come with a vision and a goal that the community has for its health going forward because I continue to hold the view that Norfolk Island has the potential to be a centre of health and wellbeing in the Pacific and that's one of my goals that I'm working towards. There's a lot of work still to be done and on my return from Sydney on the 6th June it is my intention to have a bit of a round table with a couple of Members of the Legislative Assembly here who have particular interest in this area to have further discussions before we go forward into the community consultation process. SPEAKER Question on notice No. 61. Mrs Ward to ask the Chief Minister and Minister for Tourism

MR SNELL Thank you Mr Speaker. The question reads "Will the Chief Minister provide to the House a list of apprenticeships, traineeships and related youth programs which are currently funded by the Norfolk Island Government? Mr Speaker, each year the Norfolk Island Government offers bursaries and scholarships to Norfolk Island students to enable them to continue their education elsewhere than on Norfolk Island. The following awards are available: 1. Higher School Certificate Bursary, - as the higher school certificate is available at the Norfolk Island Central School, this bursary is limited to applicants with special curriculum needs. 2. Tertiary Education Scholarship, is available to assist full time students undertaking a course leading to a tertiary qualification from a university or other tertiary institution. 3. Vocational Training Scholarship, this scholarship is available to assist persons wishing to undertake apprenticeships, technical or para-professional studies and/or training away from Norfolk Island. This year \$25,000 was budgeted for the award of bursaries and scholarships. In 2014, 21 students were successful in obtaining a Norfolk Island Government bursary or scholarship. The Norfolk Island Government also contributes a small amount each year to enable the awarding of Queen Victoria Scholarships. At the end of 2013 the Administration of Norfolk Island provided work experience for students from the Norfolk Island Central School. I am advised that this was the first time in many years that this has happened. Mr Speaker, other youth programs. There are currently two youths employed in programs which support traineeships, apprenticeships and cadetships. The Norfolk Island Airport has a Cadet who is engaged for two years until 5 November 2014.

This Cadet has completed a Certificate II in Security Operations and a number of related courses or licences in order to undertake the role of an Airport Operations Officer. Norfolk Telecom also has a Telecommunications Trainee engaged for four years due for completion on 31 January 2017. This Trainee has completed a Certificate III in Technical Security and has almost completed a Certificate III in Telecommunications Cabling. Norfolk Telecom is currently investigating additional courses training which would be relevant for the business section that this Trainee can undertake for the duration of their program. Also of note Mr Speaker, that whilst it is part of the School programme, I would like to point out that during 2014, the Norfolk Island Central School offered Vocational Education and Training for senior students, Stage 6. This school based Vocational Education and Training opportunities were in Construction, Information Technology and Hospitality and were offered at Certificate II Level. In addition, Distance Education opportunities undertaken by senior students at the School during 2014 included Tourism, Aged Care, Children's Services, Hairdressing and Equine Studies. The selection decisions are to be based on merit, where the requirements of positions are matched against the skills, knowledge, abilities and qualifications of applicants. All permanent positions will be advertised for both internal and external applicants. Eligibility lists may be utilised where the same position has been recently advertised.

The most suitable means of selecting applicants is by seeking formal applications against predetermined requirements. A representative Selection Committee will determine, based on the predetermined criteria, those applicants to be interviewed and through the interview process, the appointable candidates including the preferred applicant. Following reference checking, the Selection Committee will determine the applicant to be offered an appointment.

The selection committee will be administered by a convenor and will have the responsibility for ensuring that the most suitable applicant for the position is selected and that the selection process is based on merit. In addition, the committee will ensure that under no circumstances will there be any form of discrimination towards any applicant and all applicants are treated in accordance with equal employment opportunity guidelines.

It is a Norfolk Island Hospital Enterprise policy that the recruitment and selection process and resultant decisions be transparent, impartial, fair and equitable.

Mr. Speaker having said that, all policies at the Norfolk Island Hospital Enterprise are currently being reviewed as part of the Accreditation process; and the recruitment and selection process is yet to be reviewed. Having said that there are a few components that are now known that will be picked up in that review for this particular policy, and that is the need to include the new process for the credentialing of professional staff, criminal history and working with children checks. So whilst I table this policy today Mr. Speaker, I do so on the basis that it is currently under review as a part of the ACA process.

Now the second part of the question is asking that the Minister provide to the House the process used by the "Panel" in the recent recruitment of the Director? I will go on to quote from the response provided to me by the Chair of the recruitment panel as follows, but what's important to note is, that whilst I have tabled the Recruitment Policy for the Hospital, that is not applicable in respect of the position of the Director because that position was the process was first and foremost, provided for at 16.1 under the June 2013 Funding Agreement which provided that – the Advisory Board of the Norfolk Island Hospital Enterprise will provide the selection panel for the recruitment of the Director of the Norfolk Island Hospital Enterprise for the purposes of filling the position prior to the current Acting Director leaving the position and the panel must include representatives from each of the Commonwealth and the South Eastern Sydney Local Health District and so I will now read from what's been provided to me by the Chair of the Recruitment Panel.

"From my recollection the advertisement, the collection of respondents to the advertisement, and the compilation of candidates were performed by the Administration of Norfolk Island. (..and I think we've been through this before in the House, if not, in Meeting of Members). The Administration provided the following documents to the NIHE Advisory Board to proceed with the formulation of the recruitment panel and recruitment of the successful candidate: i. Staff Selection Guidelines; Short listing Form (Completed); Impartiality Declaration; Non-Disclosure Declaration; PD for Norfolk Island Hospital Enterprise Director; and a Copy of the Advertisement. The Norfolk Island Hospital Enterprise Director 2013-2014 Selection Panel (Panel) were appointed by the Norfolk Island Hospital Enterprise Advisory Board. The Panel undertook the following process in the NIHE Director recruitment: Signed copies of the Administration Impartiality & Non-Disclosure Agreements; Assessed each of the candidates against the PD for the Norfolk Island Hospital Enterprise Director; Shortlisted the applicants to derive the top three of five that would be considered for an interview; Contacted and documented results of the preferred candidates referees; Confirmed the candidates to

I present the following documents, **Exposure Draft Community Title Bill 2014; and Explanatory Memorandum** relating to the Bill. These documents represent a further step towards the introduction of community titles and strata titles into Norfolk Island. Members will recall that in 2012 during the term of the 13th Legislative Assembly the University of New South Wales was retained to prepare a White Paper on the introduction of strata title in Norfolk Island. The White Paper was prepared by Professor Peter Butt and Senior Lecturer, Cathy Sherry, both whom are highly regarded Australian property lawyers with a particular interest in strata titles issues. The White Paper was table in the House by Mr Sheridan in April 2012. In September 2013 this Government issued a Position Paper in response to the numerous recommendations set out in the White Paper. The Government's position was broadly in agreement with most, if not all of the White Paper recommendations. Subsequently this Community Title Bill 2014 has been developed as an Exposure Draft for public review and comment. The Bill has been drafted using South Australian legislation as a model with modifications to reflect Norfolk Island's circumstances as well as the recommendations set out in the White Paper. The Explanatory Memorandum provides a fairly comprehensive outline of the operation of the Bill. Also included is a comparison of White Paper recommendations, Norfolk Island Government Position Paper responses and references and commentary as to the implementation of the recommendations within the Bill. I also foreshadow that Exposure Draft Community Title Regulations will likely be tabled at the next meeting of the House together with details of any consequential amendments that will likely be necessary to –

The Bill and supporting memoranda presented today, although fairly lengthy documents, are not presented as representing a concluded Norfolk Island Government position on the issues arising. Public comment is particularly sought on any issues or concerns arising and internal review within the public service is ongoing. I propose to forward the documents to the Commonwealth for any comments they might care to make. I so table the documents. Mr Speaker, I take this opportunity to thank the Crown Counsel for undertaking this mammoth task to achieve the tabling of this Exposure Draft today. Thank you Mr Speaker

MS ADAMS Thank you Mr Speaker. I hadn't intended to do that today but the question earlier today regarding the Nexus Report has prompted me to table and partially read from my **Letter to Hon Jamie Briggs MP re NIHE and Health Services** in respect of health going forward.

"Norfolk Island Hospital Enterprise (NIHE) and Health Services

I refer to correspondence from you of 26 February 2014 and 10 April 2014 and mine to you of 25 March 2014. (...any my letter by the way is dated 30th April 2014).

It might be helpful if we can both reach an agreed position going forward that achieves the best outcome for the provision of health services on Norfolk Island that has both our governments support and the support of the Norfolk Island community. I hope that the following is viewed by you of my best intention in this regard.

It is an undeniable fact that you and I are both committed to working to improve health services on Norfolk Island and to ensure that those services reflect the needs of the community. (Your letter of 26 February and mine of 25 March 2014 reflect this).

I, like you, would like to see this improvement take place as speedily as possible. However, it is unfortunate that the Interim Report "*Review of Norfolk Island Health Legislation*" by Dr Tim Smyth was produced in June 2013, long before the final Calvert/Connolly "*Review of Existing Child and Family Support Services on Norfolk Island*" was available in late September 2013 and the draft "*Health Services Plan*" from Nexus Consultants not being received until the end of October 2013 without consultation being undertaken by Nexus with the doctors, the hospital staff and the Norfolk Island community. With respect, the Dr Smyth Review being undertaken in June 2013 was really a case of "horse before the cart"; a fact that I brought to the attention of the NIHE Advisory Board in my letter to them on 22 September 2013.

For the record a number of stakeholder organisations were invited to provide comment on the Nexus report which was posted on the internet shortly after it was received. However the broader community consultation is yet to be undertaken. I have attached correspondence in relation to the Nexus Report which has been received from Drs McNamara, Robbins and Sexton, medical practitioners who provide medical services to the Hospital. (...and may I say at this stage that I sought the permission of the Doctors that their letters be released).

Whilst it is regrettable that you have decided that the balance of funds advanced by the Commonwealth for Dr Smyth to complete his work could not be redirected to enable the broader community consultation to take place; the Director of the Hospital, the Minister for Finance and I are now in discussion as to how we might fund an independent and appropriately qualified facilitator to assist with this long overdue process.

The urgent need for the community consultation is further compounded by the recent ACHS Survey conducted at Norfolk Island Hospital Enterprise on 18-20 March 2014 and I quote from their High Risk Actions and recommendations at Action 1.10.3 Core –

ACHS Surveyor's recommendations

1. Progress the community consultation on the future of the NI Hospital and associated services.
2. In the interim develop and implement a clinical services capability plan to support the current scope of services being offered on the basis that this will better inform clinical staff requirements. This plan then be used to ensure appropriate, skilled and qualified staff are sourced to meet requirements.
3. Urgently review the requirements for a dedicated Director of Nursing role and implement same to ensure nursing staff are fully supported in their professional practice responsibilities.

These recommendations carry a "Risk Level: High".

As stated above recommendation 1 is under discussion and a clinical services capability plan is being developed as required in recommendation 2.

Recommendation 3 requires a minor amendment to the *Norfolk Island Hospital Act 1985* and I anticipate a Bill being introduced in the near sitting of the Legislative Assembly with a request that it be passed through all stages.

Now that the new Director of the Hospital has been appointed, I am confident that many of the outstanding issues will be resolved promptly. The Director is in regular contact by teleconference with Mr Mark Shepherd, Deputy Chief Executive of South Eastern

Sydney Local Health District (SESLHD) on how we can build on the current pathways in place with SESLHD under the Memorandum of Understanding we have with them and Sydney Children's Hospital Network.

During a teleconference on 27 April 2014 between South Eastern Sydney Local Health District representatives, Departmental Officers Ms Robyn Fleming and Mr Paul McInnes, the Director of the Norfolk Island Hospital, the Acting Chair of the Norfolk Island Hospital Enterprise Advisory Board, Ms Maria Christian (Quality Improvement Co-ordinator) and myself, the issue of accreditation, and costs associated with meeting that accreditation, were discussed. The Hospital is committed to the accreditation process through the Australian Council on Healthcare Standards and is striving to achieve accreditation within the time frames that have been set. The Hospital is working through the issues that have been identified and with the assistance of SESLHD is confident that accreditation can be achieved.

For your information, with the support of the NSW Director General of Health Dr Mary Foley the interim Chief Executive of SESLHD, Mr Gerry Marr, has been appointed as a member of the Norfolk Island Hospital Enterprise Advisory Board.

I am sure you will agree there is much work to be completed and I look forward to ongoing discussions with you as we move towards providing the best health services for Norfolk Island into the future." And that letter is signed, myself. I think that is an important document to put into Hansard and earlier on today I had said that we are moving forward as rapidly as we can with the community consultation process. STATEMENTS

MR WARD Thank you Mr Speaker. **NI Pests and Diseases Survey – Potato/Tomato Psyllid**. On the 23rd of April I was advised that the Norfolk Island Pest and Diseases Survey had detected the presence of a pest insect, generally known as a tomato /potato psyllid. This insect is a known vector for a bacterial plant disease known as Liberibacter. Tomato / Potato psyllids have been confirmed now at three localities in low numbers. Mr Speaker the discovery of this disease carrier is a serious concern for our agricultural producers and for a community that relies heavily on this local produce. It appears we are extremely fortunate that the pest has been found while still in limited distribution and density, but the need for a quick and effective response is vital. Should the psyllids and the bacteria follow the pattern of incursion into other places, the ability to grow crops such as potatoes, tomatoes and capsicums will be prone to failure to the extent that crops such as potatoes may no longer be grown. There would be a dependence upon a strict crop management which could involve a broad range of range of chemicals and other processes to produce crops. Upon confirmation of the first detection, the Australian Dept of Agriculture assisted by sending us an officer for a few days to help determine and establish an appropriate response. Delimiting survey and data collection processes have been established in conjunction with the Norfolk Island Quarantine Service. A delimiting survey commenced in the first affected area, and has now progressed to other high risk areas. The Norfolk Island Quarantine Office is continuing to progress the survey work and reports. Survey work will continue to determine distribution and density of the psyllids infestations. The results of this fieldwork will provide the basis on inform decisions with regards to whether eradication is feasible, or whether other measures need to be put in place.

All recommendations of the July and October 2013 and February 2014 Reports have been passed by the Legislative Assembly to the Norfolk Island Government for their deliberation and action. There has been no response from the Government to date other than recommendations related to Norfolk Island Culture and the South Pacific Commission.

Meetings of the Committee During Reporting Period

During the reporting period, the committee formally met on 5 occasions. Additional advice was received during informal discussions and written advice was provided to the committee.

During formal meetings 6 persons appeared before the committee. The committee wishes to record its appreciation of those who took time to appear before the committee and also those who contributed in other ways.

As reported in the last quarterly report the committee has commenced a more concentrated deliberation of issues within the private sector where previously its emphasis had been on issues of concern within what is roughly referred to as "Admin".

Issues of Concern

Whilst in no way comprehensive, the committee considers that from its deliberations during the past quarter the following are issues of major concern with readily available solutions. They are all directly related to progressing the committee's Terms of Reference. Issues which require some urgent attention are:-

1 Business Related Norfolk Island Legislation

There is a need to review all Norfolk Island legislation relevant to local business. It appears that were a review undertaken there would be shown major failings in the actual detail and enforcement of current local legislation.

Whilst some pieces of Australian legislation have been extended to include Norfolk Island, it is considered that special attention be placed, in this recommendation, on Norfolk Island legislation.

As one example of inadequacy in Norfolk Island legislation, the Australian Bankruptcy legislation does not extend to Norfolk Island so the island developed its own. This was possibly largely initiated in the belief that such legislation was required but probably would never be used. The latter summation was incorrect and the legislation has proven inadequate and an appropriate administrative structure was never initiated, thus the legislation and provision of administrative support, require urgent revision.

Other Norfolk Island Acts such as the Sale of Food Act also require urgent attention and there is a real need for proper regulation of professions such as Accountants, Lawyers, Financial Planners, Real Estate Agents etc. Whilst immigration controls may have been seen to afford some form of protection in the past, none exists under present arrangements.

Recommendation: A review of Norfolk Island Legislation relevant to business be undertaken and where necessary updated or new legislation enacted with appropriate administrative structure, as required, provided.

2 Implication of Australian Legislation currently extended to Norfolk Island

The implications of Commonwealth legislation related to business currently extending to include Norfolk Island need to be considered and potential impact on business development and investment documented. Where appropriate, discussions should be undertaken between the Norfolk Island and Commonwealth Governments.

As an example, the Foreign Investment and Take Overs Act 1975, a Commonwealth Act, has been extended to include Norfolk Island. Under the legislative framework created by the Act, a Foreign Investment Policy, administered by the Foreign Investment Review Board, has been developed.

There is a need for the Norfolk Island Government to identify and list Commonwealth legislation and attendant policies which have been extended to Norfolk Island that have potential to impact on business and investors who may wish to invest on Norfolk Island. It is essential the Norfolk Island Government is fully conversant with the impact of such

legislation and attendant policies which may exist. Such information is essential in the government dealing with both business investors and the Commonwealth Government.

Recommendation: A review be undertaken of Commonwealth legislation currently extending to Norfolk Island which may impede business or investment. The process, to identify and document specific issues, could form the basis among other things of a Norfolk Island Government approach to the Commonwealth Government on issues of concern and it seeking some resolution.

3 New Inventions and Testing Facilities

The committee is aware of several proposals, from the private sector, related to the location on Norfolk Island of research and development projects (R & D projects). Whilst the committee also understands that there may be other R & D projects seeking to base themselves on Norfolk Island there appears no clearly established process for receipt of a proposal and subsequent action by government.

Each proposal appears to be handled on an ad hoc basis by the Norfolk Island Government and there is no clear policy on how each proposal is received or assessed and the subsequent involvement of the Government or its agencies. If the islands involvement in research and development is to be progressed a formal process is urgently required.

Recommendation: The Norfolk Island Government establish a clear path which provides for the formal lodgement, assessment and acceptance or otherwise of research and development projects which may seek to be established on Norfolk Island.

4 Competition in Contractual Arrangements

The issue of competition within contractual arrangements on Norfolk Island was raised as an issue with the committee and particularly where the public sector enters as a competitor. It appears the issue is made more complex given the actual size of the island, the small market in which contractors are operating where "big jobs" are relatively rare and in some areas the amount of equipment available. Further, it should be noted the committee's role is purely one related to process and impact of that process on business not as an arbitrator or judge on individual cases.

Concerns were raised with the committee as to competition between the public and private sector being open and equitable. As an example of equitability, it is often considered that the public sector has an ability to not include all costs in quoting thus creating an unfair advantage. The reality on Norfolk Island is that the Administration has in place a policy requiring all costs to be included in quotes it prepares. The Administration policy is based on the Commonwealth Government's "Competitive Neutrality Guidelines for Managers" and all quotes prepared are subject to an audit process. Further, the Administration takes any complaints against its operations very seriously and has an established complaints process which is confidential, includes an appeal mechanism and is readily available to any potential complainant. Incidentally, there is an assumption that the private sector would include all costs in all quotes, but there is no requirement for this to occur.

Recommendation: The Norfolk Island Administration be more proactive in promoting its policies related to competition in contracting, even to the extent of providing less complex policies than those on which it currently relies for guidance.

5 Construction Standards

Evidence was provided to the committee that the documentation of construction standards required for public works are incomplete.

Recommendation: That immediate action be taken to ensure construction standards for all public works undertaken by or on behalf of, the Norfolk Island Administration are documented and publicly available.

6 Public Facilities for Norfolk Island

Public facilities on Norfolk Island have been provided by a variety of processes from those provided solely by volunteers, to those funded by the Norfolk Island or Commonwealth Governments or some combination of the above.

There appears no document available which lists public facilities which are required to fulfil a perceived need on Norfolk Island, let alone one developed on the basis of needs analysis and having been subjected to community discussion and prioritisation. The current ad hoc arrangement should cease and the Norfolk Island Government, in consultation with the community, should immediately establish a prioritised list of

required public facilities, currently identified. Such a list should then form the basis for any possible Norfolk Island Government funding and be available to the Commonwealth Government for consideration in any proposals involving Commonwealth funding.

Recommendation: The current ad hoc arrangements surrounding provision of proposed public facilities be replaced by a formal Norfolk Island Government approach. It is proposed that the government establish a list of facilities which are currently identified as "required" and following analysis on the basis of need and open community consultation, prioritise and publicise the list. Thank you Mr Speaker

MR SNELL Thank you Mr Speaker. I would like to make some comments on the Report as presented by Mr Nobbs and as a member of the committee. Mr Nobbs has quite rightly pointed out the deficiencies and in particular he has quite rightly so I believe given some slight criticism of the Government for the lack of progress in some areas. Mr Speaker this has generally been part of our problem of budget and it relates to an earlier question by Mrs Ward on some budgetary restrictions and the budgetary restrictions are mainly involved with staffing and I refer to the paper and Member around the table and the public would recognise that there is a need for more staff particularly in the Legal Services Unit area. A lot of these questions relating from this paper refer to the Legal Services Unit and they are under staffed at the present time. The Paper also has recommendations relating to the Economic Development Officer's position. Mr Speaker we were very fortunate I believe to have had the Joint Standing Committee here on Norfolk Island and on the 9th May I wrote to the Hon Jamie Briggs MP, Assistant Minister for Infrastructure and Regional Development seeking his assistance and I wrote regarding the enquiry into Economic Development on Norfolk Island and I thanked the Minister for requesting the Joint Standing Committee on the National, Capital and External Territories to conduct an enquiry into economic development on Norfolk Island and the Norfolk Island Government welcomed the opportunity to lodge a submission to the enquiry and to appear before the Committee on Tuesday 27th April 2014. Our submission outlined a number of opportunities to broaden and diversify the Island's economic base, separate to the aspirational goal of the Norfolk Island Roadmap which has a focus on the Island's principal industry of Tourism. The proposals submitted by the Norfolk Island Government are seen as opportunities to improve the revenue raising capacity of the Norfolk Island Government and the Norfolk Island Government contends that they would in the long term remove the need for the Commonwealth Government to continue to underwrite the Norfolk Island budget. The Norfolk Island Government considers that the first step in assessing and progressing any new proposals is the establishment of an economic development function which will be a key driver in economic recovery. Attachment A to our submission is a document and economic model for Norfolk Island prepared by the Administration of Norfolk Island. This document was sent under cover of a letter dated 17 April 2014 to the Hon Neil Pope, Administrator, by the Minister for Finance, Mr Sheridan seeking funding in the 2014-15 budget to establish this function. The Administration of Norfolk Island would welcome your support as a first step to the engagement of an Economic Development Officer to provide this most crucial support to the private sector. Mr Speaker, if he concerns as expressed in this Report by Mr Nobbs, can be addressed we need more staff and we need certainly an Economic Development Officer to assist in the process. Thank you Mr Speaker

In considering the service needs of children and families living on Norfolk Island the consultants took the following approach in undertaking the review – A desk review of available documents relating to the demographics of the Norfolk Island community, service statistics, earlier reviews and reports relating to the provision of Norfolk Island services; A series of community meetings that included a public meeting and meetings with specific interest groups; Meetings with Ministers in the Norfolk Island Government and the staff of the Norfolk Island Administration; Meetings with service providers across the sector; and Individual meetings with young people and families.~~

~~MRS WARD Thank you Mr Speaker. Review of existing child and family support services on Norfolk Island – This report came about as a result of the Road Map and funding agreements. If we think back to 1979 the NIG was to provide a comparable standard of services to its community. And as recently as 6 weeks ago, the NIG re-affirmed its commitment to provide mainland standard services in Education and Health (new FAG). The reality is that the NIG does not and can not deliver to its community the standard of services that are required to be delivered by State and Territory governments and we all know that and understand why. It was as a result of such issues that the previous government sat down and worked out a plan with the Cwlth on a revised way fwd for NI. The authors Marie Connolly and Gillian Calvert referred to people having multiple jobs and the effect that has on parenting. There is reference to families where someone had a disability or a mental illness, or where they were parenting alone and the challenge they faced and they noted that women had spoken to them of returning to work as soon as one week after giving birth. Perverse effects of the health insurance scheme (healthcare system that does not take into account someone's ability to pay) The authors noted – We have found the breadth, design and operation of the safety net and mutual obligation expressed through Norfolk Island's income support, taxation, health, and employment legislation and systems to be extremely limited by comparison to mainland Australia. This inadequate safety net is critically significant when seen in combination with the island's concentrated wage structure, high cost of living, increasing job insecurity, the absence of any social housing and the notably older age profile of Norfolk Island than that of the rest of Australia. Indeed the median age on Norfolk Island is 46, as compared to 37 in the rest of Australia. They also said – It was clear to us that Norfolk Island has a strong community spirit...” Several recommendations were made ... There were expected references to unhealthy levels of alcohol consumption, domestic violence and risky behaviour and what I noted was that during their time on Norfolk Island they heard of many instances of people feeling unsafe when they openly challenged issues. As a consequence we believe that informal hierarchies of power exist on the island that support cultures of intimidation and violence and that there is an atmosphere of fear that disables criticism. Unfortunately, this is something that I encounter on a regular basis and when I encourage people to stand up and say something they will not, because they fear retribution. That is why it is so important for Government and Administration to have their policies and procedures clearly identified so that there is not question of us and them – it is one rule for all and everyone understands what those rules are. I also note from reading the Report that a few people on the island expressed their doubts that families were in fact confronting real hardship. We can also read that a few people have expressed a view that introducing a stronger safety net for families could undermine the strengths of self-reliance and the strong work ethic that underpins many of the values of Norfolk Island life. We have heard those views expressed by one of our colleagues however am with the majority of people who expressed to Marie and Gillian the need to protect more vulnerable members of the Norfolk Island community in ways that are respectful of diverse needs, for example, ensuring humane responses when people lose~~

~~their jobs, when they are affected by mental illness, or when they require specialist care. There are 7 recommendations but I will read – Recommendation 1. “Norfolk Island residents should within three years, become part of the same income security, employment, taxation, child support scheme and benefit systems as other Australian residents including eligibility requirements, processes and support and participation requirements. We recognise a staged implementation may be needed in some areas, for example, early childhood education and care.” – Delaying corrective action is likely to cause an exacerbation of the problems making them more difficult, and more expensive to solve in the future I do not intend to talk about the break down of what has or hasn’t occurred so far as a result of the recommendations. – What I will do is acknowledge the work of the Office of the Administrator and the work that they have done with local community groups. – The local community service group members and helpers are the unsung hero’s in what has been achieved to date in the area of social welfare, they sometimes very quietly to improve the lives of the most vulnerable people in our community and we should all remember our fate can change at any time and acknowledge those who are there to assist. – In closing Mr. Speaker, I think that it is an opportune time to thank the soon to retire from Federal politics, the Hon. Simon Crean our previous Minister responsible for Territories. – I thank him for his efforts and his acceptance that the NI community and its welfare is ultimately the responsibility of the Federal Government. ~~In December 2012 Ms Maria Christian RN, Quality Improvement Co-ordinator for the Hospital Enterprise conducted an Assessment of how the Hospital Enterprise currently measured against the Australian Council of Healthcare Standards (ACHS). The Hospital Advisory Board has received a report from ACHS on the results of the Self-Assessment NIHE conducted last December and work to attain the status of "marked achievement" in at least the '15 mandatory criteria of the ACHS are ongoing.~~

~~An educator with the ACHS visited between 8 and 12 July to conduct sessions with hospital staff on all the standards required in order to achieve a level of accreditation as required under the Funding Agreement. Support continues to be given weekly by the Clinical Governance Unit of South East Sydney Local Health District or SESLHD via teleconferences and emails.~~

~~A visit has been arranged through the Clinical Governance Unit of the SESLHD for a Clinical Nurse Consultant to visit for one to two weeks, possibly in September, to train clinical staff in aseptic techniques. This training is part of the process for meeting the mandatory criteria of the ACHS.~~

~~Health Service Plan for the Norfolk Island Hospital and Health Service~~

~~With the assistance of the SESLHD Planning & Population Health Unit a firm, Nexus Management Consulting, was engaged to develop the Health Services Plan. I had the opportunity to meet with the Nexus Consultants, Greg Masters and Jill Hardwick, at the end of their visit in the week 29 July to 2 August. During their visit they had broad ranging discussions with key personnel in the health service area on the Island across both government and community organisations. It is intended that the report furnished by Nexus Consultants will include a description of current services; detail of health services utilisation; list of issues affecting future health service delivery; recommendations for provision of services and a proposed plan for health services.~~

~~Following discussions between the Hospital Enterprise, SESLHD and the Department of Regional Australia a Local Government, Arts and Sport, Dr Tim Smyth was engaged in late April 2013 by the Hospital Enterprise to undertake a review of the Norfolk Island Health legislation. Dr Smyth has provided the Hospital Advisory Board with his June 2013 interim report which outlines a number of key findings. The interim report is to be considered by the Hospital Enterprise and the Advisory Board in the first instance. paragraph 28A(1)(d) of the Act requires an applicant for residency under section 28A, if over the age of 18 years, to produce evidence of good character. Subsection 28A(3) however currently provides that paragraph 28A(1)(d) ceases to have effect on the date that is 10 years after this section becomes law. The amendment before us today changes that arrangement and 10 years after this section becomes law Australian citizens will no longer be required to produce evidence of good character. However New Zealand citizens will be required to continue to do so. Mr Speaker, whilst I am supportive of this amendment, I want to make the following comment. Mr Speaker as a member of the 13th and 14th Assemblies I have made it clear on many occasions that it is not appropriate for funding agreements to tell a Parliament how it should conduct its business – that it is an infringement of the independence and sovereignty of the Parliament to ask a Parliament to change a law. Clause 19.3 in the current funding agreement does just that, - it tells the parliament to change a law. In the 13th Assembly I wrote on this very matter to then Federal Minister Simon Crean pointing out that the appropriate processes are prescribed in the Norfolk Island Act 1979. On this occasion I will support the Bill but we must be mindful to not allow this to happen again in future funding agreements. In conclusion Mr Speaker I advise that the Bill before the House today has been sent as a draft to the Federal Minister for confirmation that the Bill will, once passed, satisfy the funding agreement requirement to ensure that funds are received in appropriate timing. I commend the Bill to the House.

As Members would be aware, \$7.5m for financial assistance to fund the project deficit, \$2m for ongoing governance reforms and funds to underwrite the air services to Norfolk Island. The amount provided to underwrite the air services is not for publication as negotiations with the service provider are commercial in confidence. The provision of these funds will enable the Norfolk Island Government to continue to fund essential services in the 2014-15 financial year and will now assist the Administration of Norfolk Island to prepare its annual budget with certainty. The Norfolk Island Government has written to the Hon Jamie Briggs MP Assistant Minister for Infrastructure and Regional Development, to express its sincere thanks to him, the Department of Infrastructure and Regional Development and the Administrator, the Hon Neil Pope, for their efforts in assisting Norfolk Island to secure this vital funding that will help to meet the costs of next financial year's forecast budget deficit of \$7.4m. there will be a Funding Agreement to outline the milestones to be met to receive the essential services funding and I have requested the Norfolk Island Government and the Administration of Norfolk Island receive an advance copy of the agreement so that due consideration can be given as to whether we have the resource to meet the milestone timeframes and to enable appropriate negotiations in this respect.

In terms of economic development and business moving forward, what is needed is certainty! A decision from the Federal Government so whilst I don't want to sound ungrateful, I certainly am. It will mean ongoing certainty certainly for people within the Public Service but it does very little for the private sector beyond the airline service. I'm not meaning to sound ungrateful, but until a governance model decision is made which then can be brought to this table and discussed with the Norfolk Island Government we will do nothing but to see same old same old into the next twelve months and that is unfortunately. ~~ANSWER TO QUESTION ON NOTICE NO. 19 RELATING TO IMMIGRATION~~

~~MRS WARD~~ Thank you Mr Speaker, I move I move that the House take note of Minister Adams' answer to Question on Notice (number 19) asked at the 17 July 2013 sitting of the House relating to the immigration website. The question related primarily to the need for Australian and New Zealand citizens to have onward air tickets. I will lead off by saying Mr. Speaker that this matter is in the process of being resolved however I felt that it was important to briefly speak to the motion in order to provide information to the listening community who is interested in immigration matters. It is important to me give the community an assurance that their elected representatives uphold the law and that the Minister will ensure that policy changes are implemented by the CEO of the Public Service and that if uncertainty exists, that it is clarified. Minister Adams has tabled a document titled "Discussion Paper on airline ticket policy, 13th August 2013". The first statement that the paper makes is this; "Currently there is a long standing requirement for persons other than residents to have means for onward travel from NI or to have lodged a cash bond in lieu." Question is, "should this requirement continue?" As I said this has been resolved now, but the problem was that this statement about an ongoing requirement for persons other than residents had been made null and void when the Immigration changes were assented to on the 24th of May and the changes were reflected in the New Policy and Guidelines Published on the 2nd of July. The change reflected at section 14A (4) of the Act clearly shows that "The holder of an unrestricted entry permit has the same rights under any enactment as the holder of a general entry permit...". That means that now — only a TEP (FN) needs to be considered for an onward ticket for travel out of NI. Australian and NZ citizens can travel to NI, just as we can travel to Australia or New Zealand on a one way ticket. Can I just note that any risks associated with that were analysed and identified to the Commonwealth officers last year. Where I first became aware that the changes were not being implemented was when the Immigration website went live at the end of July which led to my Question on Notice No. 19. We know that Minister Adams didn't need to bring this question to us — what she needed to do was insist that the changes were implemented based on clearly articulated and documented changes — both to the law and the policy — but the Minister did bring it to us and just so that the listening community is aware — there was strong support for the airfare issue to be clarified and that it should be removed — as is and was originally intended for Australian and NZ citizens. ~~Coming back to the answer provided by Minister Adams to my Question on Notice No. 19. Clearly it was materially wrong but — I now trust that the Minister will see that the immigration department requirements are updated. So I hope that we have managed to clear a few things up, for everyone involved. In closing — if we believe that immigration, investment and growth are key elements in our economic recovery, then we must continue to do everything we can to remove barriers and create flexibility across the board and make the recovery happen and I appreciate that takes some change in thinking.~~
