EXTENSION OF APPOINTMENT OF THE CHIEF ADMINISTRATIVE OFFICER

MR KING Mr Speaker I seek leave to move a motion in the terms appearing on the Programme concerning the Extension of Appointment of the Chief Administrative Officer

MR SPEAKER Thank you. Is leave granted? Leave is granted Mr King thank you

MR KING Mr Speaker I move that this House rescinds the Resolution of the Legislative Assembly, described as Item No 11 in the Minutes of Proceedings of 13th September 1995 headed "EXTENSION OF APPOINTMENT OF THE CHIEF ADMINISTRATIVE OFFICER"

and

THAT this House recommends to His Honour the Administrator that, in pursuance of section 8 of the Public Service Ordinance 1979, he vary as follows, the terms and conditions of the appointment of Eric Roy Mitchell as Chief Administrative Officer as determined by the Deputy Administrator on 26 March 1993 and varied by the Administrator on 25 October 1994:

Clause 1 - Period of Appointment

Omit "for two years and six months, commencing on 19 April 1993" and substitute "from 19 April 1993 to 26 November 1995".

Clause 4 - Gratuity in Lieu of Superannuation and Long Service Leave

Omit subclause 4(1) and substitute the following:

"4. (1) The officer shall receive a gratuity, in lieu of superannuation and

long service leave, payable at the end of the completed term of employment. The amount of the gratuity shall be a sum equal to 10% of the annual salary actually payable at the end of the term of employment multiplied by the duration of the term of employment expressed in terms of numbers of years and fractions of a year."

MR SPEAKER Thank you Mr King

MR KING Thank you Mr Speaker. Mr Speaker that's alot of words to correct a motion of the last Sitting, 13th September 1995, about the extension of Mr Mitchell's appointment and it proposes a replacement motion. The purpose of this procedure is to remedy the inadequate words of the earlier motion, so that proper calculation of gratuity can be made. The words "10% of annual salary" are clearly specified in this replacement motion. The motion of 13th September, was silent on this component of the calculation so basically, alot of words to correct a small error on the last occasion

MR SPEAKER Thank you Mr King. Any participation on debate in respect of that motion Honourable Members. The question before us is that that motion be agreed to
